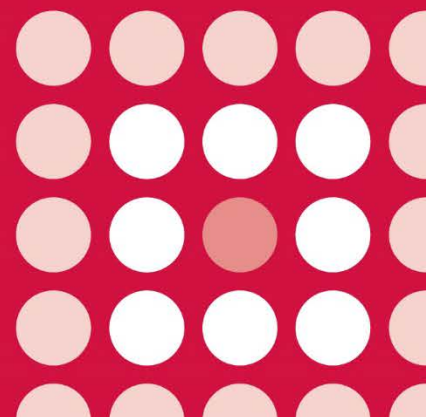

INTRODUCTION

Local Comparators are former National Prescribing Indicators which have been retired, but which may continue to be useful for some health boards to monitor. Benchmarking of certain Local Comparators may be more relevant to some health boards than others. The intention is that they are available for both local and national comparative measurement as necessary in accordance with local prioritisation. Table 1 lists the Local Comparators for 2020–2021.

Local Comparators will continue to be monitored for two years post retirement. Data will be made available on a quarterly basis via SPIRA and can be accessed by selecting the year of retirement from the drop down list on Dashboard 1 – Indicator Filter.

This document provides descriptions and specifications for the Local Comparators 2020–2021. The document lists the BNF drug name and associated BNF coding structure within the Comparative Analysis System for Prescribing Audit (CASPA) for each of the Local Comparators 2020–2021.

It should be noted that some of the drug baskets may contain medicines that have been discontinued. They are kept in the drug baskets for the purposes of historic reporting and also to identify any prescribing of discontinued medicines.
